MOTION TO BE RELIEVED AS COUNSEL

TENTATIVE RULING:

Plaintiff's counsel, Gabriella Sole (and not the entire law firm) seeks to be relieved as counsel of record for plaintiff Brian Gonzalez. If Ms. Sole no longer wishes to be counsel of record, but her firm is continuing as counsel, then this motion is unnecessary.

However, it appears from the reason provided in the motion for withdrawal, that plaintiff's counsel has been unable to communicate with plaintiff, that the entire firm is seeking to withdraw. If that is the case, then the motion is deficient.

The court **DENIES** without prejudice the motion of Ms. Sole or any other of plaintiff's counsel to withdraw. Plaintiff's counsel filed this action as a PAGA representative action (Lab. Code, §§ 2698, *et seq.*) and does not discuss what will happen to the other allegedly aggrieved employees if counsel is no longer representing plaintiff. At a minimum, plaintiff's counsel should seek other representatives if Brian Gonzalez is no longer willing or adequate to represent the allegedly aggrieved employees. (*See, e.g., La Sala v. American Sav. & Loan Assn.* (1971) 5 Cal.3d 864, 872.)
